Eligible properties are those that offer availability and a 'Pay Now' option. All costs and travel arrangements beyond the value of the voucher are the responsibility of the winner.

## **GENERAL TERMS**

### **Part A - Introduction**

1. Information on how to enter and Prize details form part of these terms and conditions.
2. By participating in the Competition, entrants accept and agree to be bound by these terms and conditions. For the avoidance of doubt, the terms and conditions include the Schedule above.
3. Entries must comply with these terms and conditions to be valid.
4. Where there is an inconsistency between the Schedule and these terms and conditions, the schedule will prevail.

### **Part B - Privacy**

5. The Promoter will collect and use each entrant's personal information for the purposes of:
  - (a) conducting the Competition and for promotional purposes, public statements and advertisements in relation to the Competition;
6. By entering the Competition, entrants consent to the use of their personal information as described in clause 5.
7. Entrants may access, change and/or update their personal information in accordance with the Promoter's privacy policy.

### **Part C - Who can enter the competition**

8. Entrants must be 18 years or over at the time of entry and must be a registered member of View Retreats at the time of the draw.
9. Directors and employees (and their immediate families) of the Promoter or its related companies are not eligible to enter. Immediate families means spouse, ex-spouse, child, step-child, parent, step-parent, legal guardian, sibling or step-sibling.

### **Part D – How to enter the competition**

10. To enter, each entrant must comply with the 'How to Enter' section of the Schedule.
11. Only one entry per entrant is permitted. Entries using multiple names or email addresses found belonging to the same entrant will be deemed ineligible.
12. The Promoter reserves the right, at any time, to request verification of the age, identity, residential address or any other information relevant to participation in the Competition of any entrant. The Promoter reserves the right to disqualify any entrant who provides false information or fails to provide information that is reasonably requested by the Promoter.
13. The Promoter reserves the right, in its sole discretion, to refuse to accept entries which are fraudulent, incomplete, indecipherable, offensive, do not comply with these terms and conditions or which contravene any applicable laws or regulations.
14. The Promoter reserves the right, in its sole discretion, to disqualify any entrant who has breached any of these terms and conditions, has engaged in unlawful or improper conduct or otherwise acts to cheat or undermine the fairness of the Competition by, for example, tampering with, or using or exploiting errors in, the entry process to obtain a competitive advantage over other entrants.

15. The eligibility of entries is solely within the discretion of the Promoter.
16. The Promoter accepts no responsibility for late, lost, misdirected or damaged entries or other communications.

#### **Part E - Prize**

17. The Prize is a voucher that is not transferrable, exchangeable or redeemable for cash.
18. The voucher is valid for 12 months from the date of issue. No extensions are possible.
19. Once the voucher has been awarded to the winner, the Promoter takes no responsibility for the voucher being lost, stolen or misused.
20. Subject to availability, the voucher can be used for booking accommodation featured on the View Retreats website up to the total value of the voucher. Any additional accommodation costs, fees, taxes, surcharges, insurance or travel costs which may be payable as a consequence of receiving a voucher are the sole responsibility of the winner.
21. The winner's use of the voucher and any subsequent booking that is made by redeeming the voucher is entirely at their own risk. The winner will be subject to the general and cancellation terms of the accommodation provider chosen upon redemption of the voucher.

#### **Part F - How the winner is determined**

22. The Competition is a game of chance.
23. At the time and date specified in the "Draw details" section of the Schedule, each valid entry will be entered into a process of random selection.
24. The winning entry or entries will be the entry that is selected in a random draw.
25. The number of winning entries to be selected will be the same as the total number of Prizes specified in the Schedule
26. The Promoters' decision will be final and binding and no correspondence with entrants or any other person will be entered into.

#### **Part G - Notification and claiming the prize**

30. The Promoter will provide the winner with instructions on how to claim their Prize. It is the responsibility of the winner to comply with the Promoter's instructions.
31. The Promoter reserves the right to request the winner to provide proof of their identity, age and/or proof that they were responsible for the winning entry.
32. The winner agrees to participate and cooperate, as required, in all publicity activities relating to the Competition, including, without limitation, being interviewed, photographed, filmed and recorded. The winner authorises the Promoter to use such content for advertising and publicity purposes in any media in perpetuity worldwide.
33. It is the responsibility of each entrant to notify the Promoter of any change to their contact details.

## **Part H - Unclaimed prizes**

34. The Promoter will take all reasonable steps to identify and notify the winner and ensure that the winner receives their Prize. However, if a winner cannot be identified or does not claim the Prize within three months of the date on which the winner is determined, their Prize is forfeited.

## **Part I – No liability**

36. The Prize is redeemable for accommodation that is supplied by a third party supplier and the winner will be subject to the terms and conditions of that third party supplier upon redeeming the Prize. The Promoter shall not be liable and excludes all liability (including negligence) for any loss or damage whatsoever which is suffered (including but not limited to indirect or consequential loss) for damage to property, personal injury or death suffered or sustained in connection with the Competition or the use or redemption of any Prize except for any liability which cannot be excluded by law including as provided for under the Australian Consumer Law.
35. If the Prize is used to book overseas accommodation, it is the sole responsibility of the entrant to ensure they and any accompanying persons hold valid passports and comply with all entry, visa, legal, health and regulatory requirements. All travel is at the entrant's own risk and the Promoter accepts no liability or responsibility whatsoever in respect of loss or injury caused during such travel.
37. If the Competition is promoted on a social networking platform, the Competition is in no way sponsored, endorsed, administered by or associated with that social networking platform and each entrant agrees to grant the platform a complete release from any claims that they now have or may have in the future which relate to or are incidental to the Competition. Entrants acknowledge and agree that:
  - (a) any information they provide in connection with the Competition is provided to the Promoter and not to any social network; and
  - (b) any questions, comments or complaints regarding the Competition will be directed to the Promoter, not to the social network platform.

## **Part J - Termination of the competition**

38. The Promoter reserves the right to vary the terms of, or cancel, the Competition at any time without liability to any entrant or other person, subject to applicable laws
